Notice Concerning Finalized Details on Issuance of Stock Acquisition Rights (Stock Option) to the Company's Directors

Symbio Pharmaceuticals Limited (“the Company”) announces that the following details have finalized today regarding the stock acquisition rights to be issued to the Company's Directors as stock options (the 43rd Series Symbio Stock Option) based on the resolution of the Board of Directors' meeting on March 29, 2018.

 - (1) Amount to be paid per one stock option : 20,300 yen
 - (2) Amount to be paid per one share : 203 yenThe person who receives the allotment of stock acquisition rights shall set off his/her claims for compensation against the Company in lieu of payment of monies for the stock acquisition rights allotted.
