## **Notice Concerning Finalized Details on Issuance of Stock Acquisition Rights (Stock Option) to the Company's Directors**

Symbio Pharmaceuticals Limited (“the Company”) announces that the following details have finalized today regarding the stock acquisition rights to be issued to the Company's Directors as stock options (the 48<sup>rd</sup> Series Symbio Stock Option) based on the resolution of the Board of Directors' meeting on March 28, 2019.

1. Number of stock acquisition rights

3,150 (in total for 6 directors)

2. Class and number of stocks to be issued upon exercise of the stock acquisition rights

The Company's common stock : 315,000 shares

3. Amount to be paid for stock options and calculation method

(1) Amount to be paid per one stock option : 19,400 yen

(2) Amount to be paid per one share : 194 yen

The person who receives the allotment of stock acquisition rights shall set off his/her claims for compensation against the Company in lieu of payment of monies for the stock acquisition rights allotted.
