**Notice Regarding the Monthly Exercise Status of the 58th and 66th Stock Acquisition Rights
 (with Exercise Price Adjustment Clause) Issued through Third-Party Allotment**

SymBio Pharmaceuticals Limited (the “Company”) hereby announces the monthly exercise status for April 2026 of the 58th Stock Acquisition Rights, which were allotted to CVI Investments, Inc. and issued on June 1, 2022, and the 66th Stock Acquisition Rights, which were allotted to EVO FUND and issued on August 12, 2025 (collectively or individually referred to as the “Stock Acquisition Rights”).

The Company is disclosing monthly exercise status for the 58th Stock Acquisition Rights, as these rights are now deemed to fall under MSCBs, etc. as defined in Article 410 of the Securities Listing Regulations established by the Tokyo Stock Exchange, following the issuance of the 65th through 67th Stock Acquisition Rights on August 12, 2025.

The exercise prices of the 67th Stock Acquisition Rights issued to EVO FUND on August 12, 2025, have been revised in line with the exercise price of the 66th Stock Acquisition Rights, as noted in “6. Exercise Status in the Relevant Month” below. However, under the purchase agreement with EVO FUND, the 67th Stock Acquisition Rights until August 13, 2027. Therefore, the Company is omitting the disclosure of their monthly exercise status.
